## **Ski Survey: Message from HACCEA**

As you all are aware, a survey was sent by Dr. Ski regarding cost-saving measures as the College prepares its 2023-2024 budget. Many of those things listed fall under what is known as "status quo" and cannot be implemented unless specifically negotiated with the union. Here is the official statement from HACCEA:

The College is free send out surveys and seek faculty input on generally any issue it would like. HACCEA, however, is the Exclusive Representative for all issues which relate to wages, hours, and terms and conditions of employment as certified by the PLRB (Pennsylvania Labor Relations Board). The parties (HACCEA and HACC) entered into an memorandum of agreement (MOA), dated August 18, 2022, which clearly sets forth the definition of status quo, retroactive to April 8<sup>th</sup>, 2022, regarding all issues related to wages, hours, and terms and conditions of employment. In accordance with our role as the Exclusive Representative and the agreement establishing status quo, should the College desire to modify status quo as of April 8<sup>th</sup>, 2022, it must do so by bargaining with HACCEA. Any modification must be committed to writing and mutually agreed upon between the parties before any modification can be implemented.

In short, admin can ask whatever they want, but any work aspects overseen by the union cannot be changed without the agreement of HACCEA due to the terms of status quo.
